THIS YEAR, 30 NEW HOMES WERE BUILT, 2 HOMES WERE REHABILITATED, 42 FAMILIES RECEIVED CRITICAL REPAIRS TO THEIR HOMES AND HUNDREDS OF OTHER MILWAUKEE RESIDENTS BENEFITTED FROM COMMUNITY DEVELOPMENT PROJECTS.
